Important Notice for Broker/Dealers

Important Change Concerning First Investors Roth IRAs

We are pleased to announce that on March 1, 2007, telephone redemption privileges will be available to all First Investors Roth IRA owners*. This will allow the transfer agent, Administrative Data Management (“ADM”), to accept telephone exchange or redemption instructions from the account owner, his or her registered representative, or any person who ADM reasonably believes is authorized to act on behalf of the account owner in accordance with procedures in the prospectus and Shareholder Manual.

We are enclosing the notice that will be in the December 31st statements advising Roth IRA owners of this new privilege. No action is required unless the owner does not want the privilege. To decline, a customer should enter the customer number, name and address, sign the form and return the bottom portion to ADM.

The Amendment to the Custodial Agreement and Disclosure Statement is printed on the reverse side of the notice. It should be retained by each customer with his/her Roth IRA documents. Any customer who opens a new Roth IRA must be given a copy of both notices. Please make sure the Amendment and opt-out notice are inserted into any existing IRA booklets you have. We are in the process of updating the booklets and will provide new supplies upon request.
